**CONDITIONS OF BOWLS SA EQUIPMENT AND BOWLS ON LOAN TO
DISTRICTS (DEV AND COACHES SC's),
NATIONAL STANDING COMMITTEES: COACHES AND ACADEMY**

The following conditions apply:

1. An annual stock inventory must be submitted to NSCD on the attached form by end April. Otherwise the stock may be withdrawn.
2. This equipment is the property of NSCD and may not be sold or given away at any time.
3. It is understood that the equipment is only on loan to a District and must be returned to NSCD if it is not in use.
4. The equipment may only be used for coaching and other development purposes and not for normal bowling activities.
5. Affiliated players may **not** play with NSCD development bowls. Once affiliated they must purchase their own bowls. The only exception to the rule is that under 19 affiliated players participating in the **U19 Dev Tournament** are allowed to play with these bowls. Please note that these bowls **may not** be used by any U25 Inter-District player."
6. It will be the soul responsibility of the District to replace any bowls that have gone missing or astray. It is therefore recommended that the district insure the equipment on loan to them.
7. If a new consignment of bowls is delivered to the district it will be necessary for a responsible person to sign the 'Acceptance Form' that must be returned to NSCD.
