

BOWLS SOUTH AFRICA MEN'S AND WOMEN'S MASTERS.

Conditions of Play for the Open, Veteran and Junior events.

All games shall be played in accordance with:

- THE LAWS OF THE SPORT OF BOWLS CRYSTAL MARK 3rd EDITION; and
- DOMESTIC REGULATIONS OF BOWLS SOUTH AFRICA; and the following;
- CONDITIONS OF PLAY

CONTROLLING BODY

The tournament shall be under the control of Bowls South Africa through its nominated Executive Member and in association with the Tournament Committee and Jury of Appeal.

JURY OF APPEAL

A Jury of Appeal appointed by Bowls South Africa will be constituted as follows:

A Member of Bowls South Africa Executive or a nominee;

A Member of the Host District's Executive Committee who shall not be a member of the tournament committee; and

The Convener of the Staging Districts Technical Officials Standing Committee or an acceptable nominee.

BOWLS – DISTINCTIVE MARKINGS, LEGALITY, REGISTRATION AND STICKERS

Bowls in a set of four must have distinctive and similar markings on each side.

Competitor's bowls shall be subject to inspection. All bowls used during the event must carry a registered stamp of either the current year or of a future year (law 53.3).

Bowls must be registered before commencement of the tournament. Players may register more than one set of bowls.

Competitors will be allocated coloured stickers for use during the tournament

FORMAT OF PLAY

Each competition will be played in two sections on a league basis to establish the winner and runner-up of each section.

SCORING AND SECTION WINNERS

In the Open, Veteran and Junior events the winner of each match shall be the player first scoring 21 shots. No shots in excess will be recorded.

One point will be recorded for each match won and the section winner shall be the player with the highest number of points. The runner-up in the section shall be the player with the next highest number of points.

If a tie the following sequential criteria will be used until a winner and runner-up are determined. Net shots, shot percentage (i.e. shots for divided by shots against), the winner of the game between the two teams during section play. If there is still a tie a one end tie breaker until a result is achieved

The section winners will play-off to determine the Gold and Silver medal winners. The section runners-up will each receive a Bronze medal

The winners and runners-up will automatically qualify for the following year's event.

ALLOCATION OF RINKS

The Tournament Committee has the right to allocate and/or change allocated rinks at any time.

DRESS AND FOOTWEAR

DRESS

All competitors must appear on the green dressed in compliance with the Laws of the Sport of Bowls. Coloured clothing may be worn, however competitors are expected to wear their highest honours.

FOOTWEAR

Players, Umpires and Markers shall wear conventional shoes or sports shoes which have a continuous sole or a sole with a channel rise in the middle of the sole, as long as the sole is clearly in one piece and the heel area does not sit at a different height to the front of the sole. To assist in traction the sole can have indented grooves up to 2 mm (thickness of matchstick), but no protuberances. The width of the rear part of the shoe shall be at least 50% of the widest part of the sole. Conventional sandals are acceptable providing they have a back strap. The National Authority reserves the right to allow or disallow the use of specific colours and brands of footwear.

WITHDRAWAL DURING THE TOURNAMENT

Should a player withdraw at any time after commencement, with or without the consent of the Controlling Body, all their completed results up to the point of withdrawal shall stand. That game and the remainder of the games shall be forfeited and the opposing player/s for that and the remaining un-played games shall be allocated one point and the net total of shots equal to the average net total of shots scored by the winners of all the other games played in the same round/s of the same section.

DIRECTION OF PLAY

Direction of play shall remain the same throughout the event

PRACTICE AND WARMUP

No green space is available for practice once the tournament has commenced

Any player may warm up prior to play commencing each day, time allowing and with the approval of the Controlling Body. During warm up bowls may be delivered to enable the player to warm/loosen up, however they must be in the opposite direction of expected play, should not be deliberate play and no target such as a jack may be used.

TOSSING FOR OPENING OF PLAY

Opponents should toss with a coin. See Law 5.2 of the Laws of the Sport of Bowls - Crystal Mark 3rd Edition.

TRIAL ENDS

One trial end in each direction may be played at the commencement of each game.

RESTRICTION OF MOVEMENT OF PLAYERS

As there are FOUR sessions played per day, therefore play must be speeded up. To this end, players may only go to the head after the player's own third bowl has been delivered, unless permission has been requested and given by the marker.

DEAD ENDS AND JACK

Should the end or jack be declared dead then the end is to be replayed.

INTERRUPTION OF PLAY

Play is to be halted immediately the siren indicating danger from lightning/thunderstorm activity is sounded and only resumed when the siren is sounded to do so.

In the event of adverse weather conditions or any other valid reason, the Tournament Committee shall have the right to curtail the number of rounds to be played and/or shots required to win a match in order to determine the winner and runners-up of each section.

SMOKING/ALCOHOL/CELL PHONES.

Smoking (including artificial or e-cigarettes such as Twisp), Alcohol, Cell Phones and Hand Held TV devices will not be permitted within 2 metres of the green while play is in progress. This ruling applies to all Tournaments under the control of Bowls South Africa.

The penalty for transgressing is as follows:

Upon the first offence the Technical Official will warn the player and record the player's name

Upon any subsequent offence by the same player, the Technical Official shall report the player to the Controlling Body, who shall take suitable action, which may include suspending the player from playing the next round. The attitude of the player and the circumstances will contribute to any decision taken by the Controlling Body.

If the offence is committed in the last round, the penalty will be carried forward to the relevant tournament for the following year.

Should a player commit a third offence he/she will be banned from taking any further part in the Tournament and be suspended from playing in any other Bowls SA Tournaments for one year.

RADIO'S

The use of "two-way" radios during play is prohibited.

DRUG TESTING

Players and their Coaches are to be aware of their responsibilities in regard to the anti-doping programme and rules of the South African Institute for Drug Free Sport.

GENERAL

If anything should arise that is not specifically covered in these Conditions of Play, then the Laws of the Sport of Bowls- Crystal Mark 3rd Edition will apply.
