### ANNUAL GENERAL MEETING

Provincial Associations (National Council) together with members of the National Convention (Workshop/Districts) are advised that a Workshop will take place at 09:00 on Saturday **30 August 2025**. The Annual National Council (AGM) meeting will be held at 09:00 on Sunday **31 August 2025**.

These meetings will be held face to face at **Wingate Park Country Club**.

### ELECTION OF OFFICE BEARERS

In terms of clause 26.1 of the Constitution only members of the National Council (Provincial Associations) are entitled to nominate persons for the Executive Committee of Bowls SA.

In terms of clause 25.3 of the Constitution the **President** and **Vice-President** were voted into office at the 2024 AGM for a period of 3 (three) consecutive years. The term of office of the current **President** and **Vice-President** therefore expires at the 2027 AGM.

The following executive members were voted into office for a period of 2 (Two) years at the 2023 AGM. Executive members term of service will expire at the 2025 AGM.

- **Arthur Langley**

The following member was voted in, at the 2024 AGM, to **fill the vacancy** left by Lyla Young been elected Vice-President replacing David Hamer who became President and as such his term of service will also expire at the 2025 AGM

Current Executive members may be nominated by the National Council Members to serve a further 2 (two) years.

It therefore follows that the election of 4 (Four) Executive Members shall take place at this AGM.

### NOTICES OF MOTION

In terms of clause 21.6 of the Constitution any Council member of the National Council (Provincial Associations), may submit motions for adoption at the National Council meeting (AGM). These motions shall be discussed and debated at the Workshop and placed before Council at the AGM for adoption. Any motions to be moved at a meeting of Council shall be in the hands of Bowls SA not later than (90) days before the date of the Council Meeting, **(3 June 2025.)**

Districts should therefore place their intended motions before their respective Provincial Associations for adoption and provide their Provincial representative with a mandate to vote at the AGM.

### GENERAL

National Council and National Convention members are requested to notify Bowls SA of any items they wish to place on the Workshop Agenda for discussion on or before 27 May 2025. The voting rights of Provincial Associations shall be determined in terms of clause 23.3 of the Constitution and be advised (45) days before the AGM. **(16 July 2025)**
