All games shall be played in accordance with:

- THE LAWS OF THE SPORT OF BOWLS CRYSTAL MARK 4th EDITION; and
- DOMESTIC REGULATIONS OF BOWLS SOUTH AFRICA; and the following;
- CONDITIONS OF PLAY

#### CONTROLLING BODY

The tournament shall be under the control of Bowls South Africa through its nominated Executive Member and in association with the Tournament Committee and Jury of Appeal.

#### JURY OF APPEAL

The Executive will appoint the Jury of Appeal consisting of:

- A member of the Bowls SA Executive, failing that a person nominated by the Executive at their sole discretion.
- A member of the Host District's Executive Committee, who is not a Member of the Tournament Committee.
- A member of the National Standing Committee: Technical Officials (NSCTO) or, in the absence of such a member, the Convenor of the staging District's Technical Officials Standing Committee or their nominee (may not be a member of the Events Committee).
- A person with a legal background, as nominated by the Bowls SA Executive Committee. (Need not be present at the Event).

The decisions of the Jury of Appeal shall be final.

#### 1. BOWLS – DISTINCTIVE MARKINGS, LEGALITY, REGISTRATION AND STICKERS

Bowls in a set of four must have distinctive and similar markings on each side. Competitor's bowls shall be subject to inspection. All bowls used during the event must carry a registered stamp of either the current year or of a future year (law 53.3).

Bowls must be registered before commencement of the tournament. Players may register more than one set of bowls.

Competitors will be allocated coloured stickers for use during the tournament.

## **2. COACHES**

Players may nominate a coach at the commencement of the tournament. The coach needs to be suitably attired and wear some form of Identification (eg Sticker). The coach may communicate with the player off the green. Since this is a major event, which includes the top tier of bowlers in the country, coaching consultations should be kept to a minimum

## **3. FORMAT OF PLAY**

Each competition will be played in two sections on a league basis to establish the winner and runner-up of each section.

## **4. SCORING AND SECTION WINNERS**

In the Open, Veteran and Junior events the winner of each match shall be the player first scoring 21 shots. No shots in excess of 21 will be recorded.

One point will be recorded for each match won.

The section winners and runners-up shall be decided on the following sequential criteria: -

- 4.1 Highest number of game points scored
- 4.2 Shot Aggregate (Total shots for minus total shots against)
- 4.3 Shot percentage (Total shots for divided by total shots against).
- 4.4 If game points, shot aggregate and shot percentage are equal, the winner of the game between the two players during section play
- 4.5 If there are 3 or more players with equal no of points, shot aggregate, shot percentage then there will be a 1 end tie break end between the players involved. Toss to decide who plays first, second, third. (1 trial end, 2 bowls each)

The section winners will play-off to determine the gold and silver medal winners. The section runners-up will each receive a bronze medal.

The winners and runners-up of the event will automatically qualify for the following year's event.

## **5. THE DRAW, ALLOCATION OF RINKS AND COLOURED DISCS**

Bowls SA will prepare the Draw, arrange method of play, allocate rinks, and will publish the draw with copies to the Committee, who shall provide coloured discs indicated by Bowls SA.

## **6. DRESS AND FOOTWEAR**

### **6.1 DRESS**

All competitors must appear on the green dressed in compliance with the Laws of the Sport of Bowls. Competitors are expected to wear their highest honours.

## **6.2 FOOTWEAR**

Players, Umpires and Markers shall wear conventional shoes or sports shoes which have a continuous sole or a sole with a channel rise in the middle of the sole, as long as the sole is clearly in one piece and the heel area does not sit at a different height to the front of the sole. To assist in traction the sole can have indented grooves up to 2 mm (thickness of matchstick), but no protuberances. The width of the rear part of the shoe shall be at least 50% of the widest part of the sole. Conventional sandals are acceptable providing they have a back strap. The National Authority reserves the right to allow or disallow the use of specific colours and brands of footwear.

## **7. WITHDRAWAL DURING THE TOURNAMENT**

Should a player withdraw at any time after commencement, with or without the consent of the Controlling Body, all their completed results up to the point of withdrawal shall stand. That game and the remainder of the games shall be forfeited and the opposing player/s for that and the remaining un-played games shall be allocated one point and the net total of shots equal to the average net total of shots scored by the winners of all the other games played in the same round/s of the same section.

## **8. DIRECTION OF PLAY**

Direction of play shall remain the same throughout the event

## **9. PRACTICE AND WARMUP**

Practice facilities to be arranged on Thursday afternoon by the Tournament Committee.

No green space will be available for practice once the tournament has commenced. Any player may warm up prior to play commencing each day, time allowing and with the approval of the Controlling Body. During warm up bowls may be delivered to enable the player to warm/loosen up, however they must be in the opposite direction of expected play, should not be deliberate play and no target such as a jack may be used.

## **10. TOSSING FOR OPENING OF PLAY**

Opponents should toss with a coin. Refer Law 5.2 of the Laws of the Sport of Bowls - Crystal Mark 4th Edition.

## **11. TRIAL ENDS**

One trial end in each direction may be played at the commencement of each game.

## **12. RESTRICTION OF MOVEMENT OF PLAYERS**

As there are FOUR sessions played per day, **play must be speeded up**. To this end, players may only go to the head after the player's own third bowl has been delivered, unless permission has been requested and given by the marker.

## **13. DEAD ENDS AND JACK**

Should the end or jack be declared dead then the end must be replayed. Refer law 20.2 in the Laws of the Sport of Bowls - Crystal Mark 4th Edition.

#### **14. INTERRUPTION OF PLAY**

Play is to be halted immediately the siren indicating danger from lightning/thunderstorm activity is sounded and only resumed when the siren is sounded to do so.

In the event of adverse weather conditions or any other valid reason, the Tournament Committee shall have the right to curtail the number of rounds to be played and/or shots required to win a match in order to determine the winner and runners-up of each section.

#### **15. SMOKING/ALCOHOL/CELL PHONES.**

Smoking (including artificial or e-cigarettes such as Twisp), Alcohol, Cell Phones and any other technical devices will not be permitted within 2 metres of the green while play is in progress. This ruling applies to all Tournaments under the control of Bowls South Africa.

Where *live scoring* apps are used, the designated person on the rink may use a cell phone for the purposes of live scoring only.

The penalty for transgressing is as follows:

15.1 Upon the first offence the Technical Official will warn the player and record the player's name

15.2 Upon any subsequent offence by the same player, the Technical Official shall report the player to the Controlling Body, who shall take suitable action, which may include suspending the player from playing the next round. The attitude of the player and the circumstances will contribute to any decision taken by the Controlling Body.

15.3 If the offence is committed in the last round, the penalty will be carried forward to the relevant tournament for the following year.

Should a player commit a third offence he/she will be banned from taking any further part in the Tournament and be suspended from playing in any other Bowls SA Tournaments for one year.

#### **16. RADIO'S**

The use of "two-way" radios during play is prohibited.

#### **17. DRUG TESTING**

Players and their Coaches are to be aware of their responsibilities in regard to the anti-doping program and rules of the South African Institute for Drug Free Sport.

#### **18. GENERAL**

If anything should arise that is not specifically covered in these Conditions of Play, then the Laws of the Sport of Bowls- Crystal Mark 4th Edition will apply.
