ELECTION OF OFFICE BEARERS

In terms of clause 26.1 of the Constitution only members of the National Council (Provincial Associations) are entitled to nominate persons for the Executive Committee of Bowls SA.

In terms of clause 25.3 of the Constitution the **President** and **Vice-President** were voted into office at the 2024 AGM for a period of 3 (three) consecutive years. The term of office of the current **President** and **Vice-President** therefore expires at the 2028 AGM, due to the AGM moving from August to June.
